The Main Topic: How to deal with difficult people.

### **Problem People**

1. Keep focused on what is good for the club, not individual skaters.
2. Get all of the facts and treat it like a club issue, not an individual issue.
3. For board meetings, have a set agenda and timebox topics.
4. Dismiss people that are trying to derail a meeting.
5. Sleep on inflammatory emails.
6. Practice maximum transparency.
7. Address issues in a timely and factual manner.

### **Conflict Resolution**

1. The Bylaws should have a conflict resolution procedure.
2. Should have a set timeframe to resolution.
3. Club procedures must be followed before escalation to USFS. There is a filing fee for USFS conflict resolution.
4. Find impartial parties to try and resolve the issue locally, if possible.

### **USFS Updates**

1. Overall membership numbers steady, but L2S down. Investigating.
2. Read through Safe Sport handbook.
3. Board nominations due.

### **The Main Topic: Test Refresh**

Discussed the new option and procedure to allow Skaters to count their IJS competition events as tests. Recommended charging \$20 to \$25 for the event packet that is required to present to the testing committee because we still have to pay test fees for this testing option. We will have to really study this procedure for Hiawathaland and possibly communicate up front with IJS skaters to see who might be considering this. Judges need to ready for this, also, because I believe they have to fill out additional paperwork. The Accountant definitely has more to do.
